TAX LEVY OF THE VILLAGE OF MIDDLETOWN ILLINOIS, FOR THE
CORPORATE YEAR BEGINNING MAY 1, 2016
AND ENDING THE 30TH DAY OF APRIL 2017

An ordinance levying taxes for all corporate purposes for the Village of Middletown, Logan County, Illinois, for the fiscal year beginning May 1, 2016 and ending April 30, 2017.

BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF MIDDLETOWN, LOGAN COUNTY, ILLINOIS AS FOLLOWS:

SECTION 1: That the amount hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Water, Motor Fuel Tax, Social Security and Insurance for the fiscal year commencing May 1, 2016 and ending the 30th day of April, 2017. The total sum of SEVEN THOUSAND THREE HUNDRED TWENTY TWO DOLLARS (\$7,322.00) for the following specific purposes mentioned as follows to wit:

SECTION 3: That is any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 4: That this ordinance shall be in full force and effect after its adoption, as provided by law.


