ORDINANCE NO. 2020-0002

**TAX LEVY OF THE VILLAGE OF MIDDLETOWN ILLINOIS, FOR THE
CORPORATE YEAR BEGINNING MAY 1, 2019
AND ENDING THE 30TH DAY OF APRIL 2020**

An ordinance levying taxes for all corporate purposes for the Village of Middletown, Logan County, Illinois, for the fiscal year beginning May 1, 2019 and ending April 30, 2020.

**BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF TRUSTEES
OF THE VILLAGE OF MIDDLETOWN, LOGAN COUNTY, ILLINOIS AS FOLLOWS:**

SECTION 1: That the amount hereinafter set forth, or so much thereof as may be authorized by law, and the same are hereby levied upon all property subject to taxation within the municipality as that property is assessed and equalized for the current year, and for such purposes as: General Corporate, Water, Motor Fuel Tax, Social Security and Insurance for the fiscal year commencing May 1, 2019 and ending the 30th day of April, 2020. The total sum of **SEVEN THOUSAND SIX HUNDRED FIFTY FIVE DOLLARS (\$7,655.00)** for the following specific purposes mentioned as follows to wit:

SECTION 2: That the Village Clerk shall make and file with County Clerk of said County of Logan, on or before the last Tuesday in December, duly certified copy of the ordinance.

SECTION 3: That is any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of this ordinance.

SECTION 4: That this ordinance shall be in full force and effect after its adoption, as provided by law.


