ORDINANCE AMENDING MUNICIPAL WATER DEPARTMENT
RULES AND REGULATIONS

WHEREAS, the Village of Middletown, Logan County, Illinois, has the power and jurisdiction to regulate the installation, charge and use of the water supplied by the Village of Middletown; and

WHEREAS, the Village Board of Trustees of the Village of Middletown, State of Illinois, has previously enacted certain ordinances and resolutions regulating the installation charge and use of water supplied by the Village of Middletown and

WHEREAS, the Board of Trustees of the Village of Middletown find that such ordinances and resolutions heretofore adopted should be amended.

NOW THEREFORE BE IT ORDAINED, by the Village Board of Trustees, of the Village of Middletown and State of Illinois, as follows:


Section 2.3: WATER USER RATES


1. \$17.00 per month for the first 2,000 gallons; and
2. \$10.00 per month for each 1,000 gallons; and in excess of the 2,000 gallons base rate.

BE IT further ordained by the Village Board of Middletown, Logan County, Illinois that this Ordinance No. 2022-0003 amending Municipal Water Department Rules and Regulations inclusively shall be in full force and effect upon approval and publication according to law. Upon passage the Village of Middletown Clerk is directed to post a copy of this ordinance as required by the statute.


